We invite applications for the position of Program Director in the Community and Social Justice Division (CSJ). This is a regular, full-time position, reporting to the Dean, Health, Community and Social Justice (SHCSJ). This position is based at JIBC's New Westminster, BC campus.

Experience in contract training, client relations management, proposal development, contract costing/pricing and negotiation is important. Demonstrated success inspiring and building trusting, strategic relationships is essential as is experience leading complex projects, faculty facilitation and community engagement.

Qualifications & Requirements:

- Graduate degree in related discipline (e.g., conflict resolution, leadership, education, peace studies) or an acceptable equivalent combination of education, experience and training, along with an in-depth understanding of and experience in the post-secondary educational service.
- A minimum of 5 years' mid-level experience in educational leadership and administration, including team leadership, program development and delivery, strategic planning, financial management, business development and project management.

We offer a total compensation package that includes a benefit plan, which includes Extended Health and Dental Benefits after three months, and enrollment in the College Pension Plan upon hire.
