The School offers a wide range of interdisciplinary programs and courses in counselling and community safety, leadership, conflict resolution, mediation and negotiation, as well as courses and programs in paramedicine and professional health education.

## **Position Summary:**

Community and Social Justice Division (CSJD) seeks an experienced manager with business acumen and a passion for conflict resolution, leadership, and social justice training. The successful applicant will be responsible for managing all aspects of customized training business relations, planning and delivery, targeting business, government and community-based organizations as primary clients. This position provides leadership to the Customized Training Team to advance effectiveness in aligning and connecting CSJD training to meet stakeholder needs, as well as working collaboratively with the CSJD leadership team and other internal colleagues to further the strategic goals of JIBC.

# **Primary Responsibilities:**

Working closely with the Program Director and in collaboration with Centre program staff:

- Develops a strong business model approach to the identification, development and delivery of customized training for existing and new clients and markets;
- Develops and maintains strong relationships with businesses, government ministries and agencies, First Nations communities, and a diversity of organizations for delivery of courses and programs;
- Monitors business/sector trends and contributes to the Centres' business approach;
- Conducts and manages all aspects of customized program delivery including: business development, indepth needs analysis, course customization and evaluation, RFP response, financial management, and dayto-day supervision of instructor/coach assignments;
- Conducts presentations for stakeholders and potential clients to identify and develop business opportunities;
- Tracks contract activity and facilitates promotional tactics for customized training;
- Monitors government sites for and preparing responses/quotes to relevant Request for Proposal (RFP)
  opportunities;
- Collaborates with other JIBC divisions and academies on common program or client interests;
- Provides consultation and direction to students, agencies and organizations seeking assistance and guidance on training and professional development needs in the areas of conflict resolution, leadership and social justice;
- Manages all financial aspects of Customized Community and Social Justice training including budgets, variances, and forecasts;
- Monitors contract revenues and expenses and related financial matters;
- Reviews and approves invoices, time sheets, expense claims, and leave forms within area of responsibility;
- Participates as a team member in the development of new credentials and courses;
- Participates in the recruitment of new faculty;
- Represents CSJ on various JIBC committees and task groups;
- Other related duties as assigned.

- Master's Degree in a relevant field (adult education, conflict analysis, peace studies, leadership, counselling, community safety);
- JIBC Certificate in Conflict Resolution or Leadership or equivalent;
- Or an acceptable equivalent combination of education, training and experience.
